I understand you are under consideration of significant changes affecting the Franchise Broker market. I am writing to voice my concern over the proposed changes and ask that the proposal be tabled for further study or termination.

As a newer Franchise Broker in the industry, with just under 2 year experience, I have been incredibly impressed by the caliber of many of Franchise system and the business ownership opportunity they provide to hard working Americans. I chose to join the Franchise Broker industry due to the opportunity to impact lives. By helping individuals at the mid-point of their career transition to business ownership where they can leverage their skills learned in corporate America to provide new job opportunities, services, and impact to their communities.

As I learn about the proposed regulations, I can assure you that your well-intentioned regulations will have significant negative impacts on my businesses, on the franchise industry and the economy as a whole.

I fully support actions to ensure poor behavior in this, and any industry, are mitigated and legally prohibited. However, the regulations proposed appear to be overly broad, expand the scope of the industry, increase liability for unsuspecting participants, increase disclosure complexity which creates unfair and excessive burden and as a result will have major unintended consequences.
