- Brokers add value to the franchise award process by promoting transparency and accountability.
- We reduce risk for franchisors and franchisees by ensuring candidates understand responsibilities and evaluation steps.

## • Concerns with State-by-State Fees

- A fragmented fee structure would harm franchisors, prospective franchisees, and brokers alike.
- Instead, one **national educational program** would address legitimate education concerns without placing undue financial or administrative burden on states, franchisors, or brokers.

#### • The Marketplace Has Changed

• Regional territory restrictions no longer reflect today's national, online-

driven franchise development marketplace.

- Historically, regional models worked, but as the industry evolved, networks with outdated models struggled.
- Reintroducing state-by-state registration requirements would be a step backward, harming business growth in each state.

Collaboration is key. A balanced, modernized approach—such as a national education course—supports consumer protection while allowing franchising to continue driving economic growth and local job creation.
